ALL that certain piece, parcel or lot of land, with the improvements thereon, situated, lying and being in Greenville County, South Carolina, being known and designated as Lot 93, and the northern one-half of Lot 92, Block C, as shown on a plat of the subdivision of City View, recorded in the Office of the R.M.C. for said County in Plat Book A, Page 460, and described more particularly as follows:

BEGINNING at a stake on the eastern side of McDade Street, in the center of Lot No. 92, said stake being 81 feet from the corner of New Cut Road and McDade Street, and running thence N ½ E, 75 feet along McDade Street to a stake, corner of Lots No. 93 and 94; thence S 89-30 E, 150 feet along the dividing line of Lots 93 and 94 to a stake on a ten foot alley; thence along said alley S ½ W, 75 feet to a stake in the center of Lot No. 92; thence through the center of Lot No. 92 N 89-30 W, 150 feet to the beginning corner.
