the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto ROBERT M. PETERSON AND KAREN A. PETERSON

1.91-acre Tract: ALL that certain piece, parcel or tract of land situate on the southern side of Dug Hill Road, in the County of Greenville, State of South Carolina, being shown as a tract containing 1.91 acres on a plat of the property of Archie L. Durham, Ola D. Campbell, et al, dated August 5, 1981, prepared by Sam T. Marlowe & Associates, recorded in Plat Book 11-B at page 29 in the R.M.C.
