to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s), the receipt of which is hereby acknowledged. Law granted, bargained, sold and released, by these presents do grant, bargain sell and release unto Betty C. Campbell, her heirs and assigns forever:

ALL that piece, parcel or lot of land situate, lying and being in Austin Township, Greenville County, South Carolina, just East of the Town of Mauldin, designated as Lot No. 14 on plat prepared by C. C. Jones and Associates for Leo B. Champion in May, 1955, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Sunrise Drive, the joint front corner of Lots Nos. 14 and 15, as shown on said plat, running thence N. 10-47 E. 210.2 feet to an iron pin; thence N. 72-58 E. 130.7 feet to an iron pin; thence S. 11-42 E. 209.3 feet to an iron pin on the Northern side of Sunrise Drive; thence S. 72-30 E. 100 feet along the Northern side of Sunrise Drive to the point of beginning.

This is the same property originally conveyed by the above Grantor and his late wife, Mae Champion, to their only daughter, Betty C. Adams, now Betty C. Campbell, and the latter's former husband, James W. Adams by deed dated May 13, 1955 recorded in Deed Book 525 at Page 453. Through inadvertance only a life estate was conveyed in said deed in that words of inheritance was omitted in both the habendum and granting clauses of said deed. Subsequently James W. Adams conveyed his one-half interest in the property as a life tenant to the said Betty Adams by deed dated May 9, 1961 recorded in Deed Book 675 at Page 280. Mae Champion died testate devising all of her property to Leo B. Champion, the Grantor herein, as shown by reference to Apartment 101 at file # , Records of the Probate for said county. It is the intent of this deed to vest in Betty C. Campbell (formerly Betty C. Adams) a fee simple title to said property.
