The expression or designation "Grantor" wherever used herein shall be understood to include the Mortgagee, if any here he.
2. The right-of-way is to and does convey to the Grantee, its successors and assigns the following: The right and privilege f entering the aforesaid strip of land, and to construct, maintain and operate within the limits of same, pipe lines, manholes, and any other adjuncts deemed by the Grantee to be necessary for the purpose of conveying sanitary sewage and industral castes, and to make such relocations, changes, renewals, substitutions, replacements and additions of or to the same from fine to time as said Grantee may deem desirable; the right at all times to cut away and keep clear, of said pipe lines any and all egetation that might, in the opinion of the Grantee, endanger or injure the pipe lines or their appurtenances, or interfere with heir proper operation or maintenance; the right of ingress to and excess from said strip of land across the land referred to hove for the purpose of exercising the rights herein granted; provided that the failure of the Grantee to exercise any of the lights herein granted shall not be construed as a waiver or abandonment of the right thereafter at any time and from lime to exercise any or all of same. No building shall be erected over said sewer pipe line nor so close thereto as to impose any or all the same.
3. 7. In the event plans for said sewer lines are cancelled or altered and this right of-way is not needed, then same may be ancelled and no money shall be due the Grantors. The pay next of the consideration for this right of-way shall be made before onstruction commences.
