- the Receipt whereof is hereby acknowledged he the said James M. Williams hath bar-
- gained and sold and by these presents doth bargain and sell all that plantation
- or tract of one hundred and forty acres of land being part of a tract of land of six
- hundred and forty acres granted unto the said James M. Williams by patent bear-
- ing date the twenty first day of January one thousand seven hundred and Eigh-
- ty five lying on Keedy River above the Antient boundary line, Bounded N^o East
- by the said River and South by a part of the said tract laid out to Matthew Am-
- strong supposed to contain one hundred and forty acres be the same more or less
- left together with all and singular the houses, out houses, Edifices, Buildings, barns
- Stables, yards, gardens, Orchards trees Woods, under Woods, Ways, Waters, Water Courses,
- Hereditaments, and appurtenances as also the Reversion and Reversions Rema-
