ford County & State of North Carolina of the one part, & Samuel
Queen of the County Buncombe & State of North Carolina of the other
part witnesseth that the said William Queen for and in consideration
of the sum fifty pounds Sterling Money well and truly paid by the s^d
Samuel Queen at and before the sealing and delivering of these presents
the receipt whereof the said William Queen doth hereby acknowledge and
thereof & of firmly every part and parcel thereof do acquit & discharge
the said Queen and his heirs & assigns and for diverse other good causes
and consideration hereunto moving have granted & bargained &
sold others enfeoffed confirm unto the s^d Samuel Queen and assigns
for ever all that parcel or tract of land lying & being in Greenville
County in the State of South Carolina on a branch of Reedy River
on the south side of said River containing one hundred & Ninety
three acres it being part of a larger Tract by one thousand acres
Originally granted to the said John Lafferty & begining at a Read
oak from thence to a tree Blackstone for compliment Religiously
granted to the said John Lafferty & signed by his Excellency Thomas
Pinckney the twenty fourth day of September one thousand seven
hundred & eighty eight by a plat annexed the s^d Grant will more
fully appear together with all and singular the hereditaments &
appurtenances at whatsoever to the s^d Tract of land so described
above belonging or in any wise appertaining & the reversions
or Reversions remainder or remainders rents or shers & profits
share of & every part or parcel thereon of & all estate right title
