 Doth hereby acknowledge & thereof & every part & parcel thereof doth
 & discharge the s^d Jonathan Stone his heirs Executors Adminis-
 trators & assigns forever have given granted bargained & sold & by these
 presents do bargain sell release convey & confirm unto the s^d Jon-
 athan Stone his heirs Executors &c, forever one certain tract or
 parcel of land lying & being in Granville County on the south
 West side of Mountain Creek containing by computation one
 hundred & fifteen Acres (or the same more or less) and bounded
 as followeth, Beginning at a Hickory bush on s^d Brunk's
 line thence N^o 35 W^o 14° 25' to the Creek thence on the same course 35
 till it intersects with s^d Brunk's S^o 44^o line ^{thence} 10 E^o 44^o 25' L.
 to a small ash on the Creek thence down the various Manders of the
 Creek passing the Mill Dam & Mill to about 106. of the lower
 line thence across the Creek S^o 87^o E^o chains to a stake thence S^o 5^o w
 13^o to the beginning Together with all houses orchards gardens
 Meadows pastures felling fences woods underwoods ways waters & water-
 courses Together with all the Estate right title Interest possession
 claim & demand what ever of him the s^d Christopher Brunk in
 or the same or any part of the Rents & Reversions Remainder
 & Remainders of all and singular the aforesigned premises
 & Ferry of their appurtenances To have and to hold the s^d
