The following Deed of Conveyance from Larkin Tarrant to Levi Faris being proven before Robert Maxwell Esq^r by the oath of Isaac Bowen was presented and Recorded this 26th day of April A^d 1796 in South Carolina Greenville County This Indenture made the twenty first day of March in the year of our Lord one thousand seven hundred & ninety four & eighteenth year of America's Independance between Larkin Tarrant of the State & County aforesaid of the one part & Levi Faris of said County & State of the other part witnesseth that the said Larkin Tarrant hath this day bargained sold delivered aliened, released & confirmed by these presents doth bargain sell deliver alien release & confirm unto the said Levi Faris his heirs and assigns for ever all that plantation or tract of Land containing one hundred & twenty four acres situate in the County afores^d on Saluda River bounded by running NW & NE by Richard Bryants land S^o E^o & N^o E^o by Sept Duhcans Land S^o E^o by Robert Maxwell Land S^o W^o & S^o E^o by Ambrose Blackburns Land S^o W^o by Henry Langfords Land & that such shape and marks as the Original survey doth represent granted to s^d Larkin Tarrant by his Excellency Charles Pinckney Esq^r on the seventh day of February one thousand seven hundred and ninety one Recorded in Book C N^o 5 page 260 and hereby fees the warrant & defend in the said Levi Faris his heirs & assigns for very good & uninterrupted right & possession either from myself heirs or other assigns or any other person or persons claiming the same having received in full consideration for the same the sum of twenty five pounds Sterling the receipt whereof for the purpose aforesaid I do hereby acknowledge, I witness whereof I hereby set my hand seal the day and date above written
