A. A page 116 then from the James Reynolds by lease and release part of the S^t tract to Michael Parkle &c. the second being granted to Michael Parkle a tract of four hundred acres on Reedy River then in the district of Ninety six bearing date soon been hundred and eighty four signed by his S^t Excellency Benj^r Llward &c Recorded in grant Book E. E. E. page 328 &c. the third also granted to Michael Parkle being a tract of two hundred acres on Reedy River then in the district of ninety six bearing date 17th seventeen hundred eighty eight signed by his Excellency William Moultrie Esq^r Governor in chief in & over said State Recorded in Grant Book E. E. E. page 513 Now this Indenture witnesseth that he the said Michael Parkle and Barbary his wife hath for & in consideration of the sum three hundred pounds sterling to him in hand paid by the S^t Hudson Berry the Receipt whereof is hereby acknowledged hath bargained and sold unto the S^t Hudson Berry a tract of land containing three hundred & seventy five acres situate in Greenville County on both sides of Reedy River it being a part of the above mentioned three tracts begining on the North Bank of S^t River and crossing S^t River and Runing with the old line S.W. 24 supposed about 38 ch to post oak corner of the old tract thence N.W. 66 1/2 ch 50L to a Stake thence S.W. 50 1/4 ch to a stake, then N.W. about 60 about 6 or 7 ch to a Stake thence S.W. 20 3/4 ch to a stake thence S.E. 70 38 ch 50L to arid oak thence S.E. 40 - 35 ch to a Hury, thence N.E. 50 crossing the S^t River including 6 foot of land on the N side of S^t River, then up S^t River within six foot of the water to the upper end of the shoal, then bounding on S^t River to the begining Including the plantation of S^t Michael Parkle where he now lives together with the said Hill &c. and by these presents doth bargain sell make over alien & confirm and convey unto the S^t Hudson Berry his heirs and assigns for ever the above tract of three hundred & seventy five acres of land together with the appurtenances thereto belonging or in any wise appertaining with all the buildings and water Courses with the remainder and remainders, reversion & Reversions rents profits advantages Issues Intents claims & demands unto the S^t Hudson Berry his heirs and assigns to have and to hold the S^t Michael Parkle's Tenement of three hundred & seventy five acres of land as above mentioned to the only proper and absolute use & behoof of the said Hudson Berry his heirs & assigns for ever the S^t Hudson Berry shall & may from time to time & at all times hereafter occupy possess & enjoy the premises free & clear from all manner of hindrance Interruption molestation or denial from him the S^t Michael Parkle his heirs & assigns and lastly he the S^t Michael Parkle & Barbary his wife from the 1st day of April 17th one thousand seven hundred and eighty eight from any hindrance arising
