

486 South Carolina This Indenture made the 4th day of March in the
year of our Lord one thousand seven hundred and ninety seven between
Robert Carter & Esther his wife of Greenville County State aforesaid of
the one part and Wilson McKinney of the same and county aforesaid of
the other part witnesseth that the said Robert Carter & Esther his wife
for and in consideration of the sum of two hundred and sixty Dollars
to them the said Robert Carter & Esther his wife in hand paid by the
said Wilson McKinney the receipt whereof is hereby acknowledged
they the said Robert Carter & Esther his wife hath granted bargained &
sold, aliened, released, conveyed, and confirmed, and these presents doth
grant bargain & sell, convey & confirm unto the said Wilson McKinney
his heirs and assigns for ever a tract of land containing two hundred &
forty seven acres, the same being granted to Esther Thomas (now the wife of
the said Robert Carter) by a grant under the hand of Benjamin Goad Esq.
the then Governor of said State with the great seal of said State thereto affi-
ed dated the 15th day of October 1785 and duly Recorded in the Secretary's off-
ice said land lying on both sides of the south fork of Musch Creek toge-
ther with all trees woods under woods fedges commons profits ways waters
and appurtenances whatsoever thereunto belonging, and the reversion and
reversions remainder & all the estate right title claim & demand what-
soever of them the said Robert Carter & Esther his wife or in & to the said
Tract of land and premises abovementioned and every part thereof
thereof to the only use and behoof of him the said Wilson McKinney
for ever and the said Robert Carter & Esther his wife for them & theirs &
against their and every of them unto the said Wilson McKinney his his
heirs Executors Administrators and assigns shall and will warrant from
all and every other person or persons lawfully claiming the same in
witness whereof they the said Robert Carter and Esther his wife have
hereunto set their hands & affixed their seals the day & year first above written
