87 The following Deed of conveyance from Edward Mitcherson to John Westmoreland being proven before James Hilgore Esq. by the oath of John Cantrell was presented and recorded this 8th Day of August 1798 State of South Carolina. Know all men by these presents that Edward Mitcherson of the County and State aforesaid in consideration of the sum of eight hundred and fifty one Dollars to me in hand paid by John Westmoreland of the County and State aforesaid have granted bargained and sold and released and by these presents do grant bargain and sell and release unto the said John Westmoreland a parcel of land containing two

hundred and fifty acres beginning at a stone on the south line of said tract running North 24. E. Chains and 25 Links to a white oak marked with light chops thence N. 31. E. 12. Chains 65 Links to a Pecan with eight chops thence S. 70. N. 10. chains to red oak and stake at a branch then down the said branch to Golden Creek and a cross Creek to the north side of said Creek then down the Creek to Moore River the upper River with the various courses of the River to where the upper line of said land intersects with the River then with the courses of said land to the beginning including all that tract of land whereof the persons now lives together with all and singular the Rights Remainders Hereditaments and appurtenances to the said premises belonging or in any wise appertaining to have and to hold & singular the premises before mentioned unto the said John Westmoreland his heirs and assigns forever and I Edward Mitcherson upon this hereby bind myself my heirs Executors and administrators to warrant and forever defend all and singular the said premises of two hundred and fifty acres be the same more or less unto the said John Westmoreland his heirs and assigns against myself and my heirs and against every Person whomsoever lawfully claiming or to claim the same or any part thereof in witness whereof have hereunto set my hand and seal this twenty eighth day of February in the year of our Lord one thousand seven hundred and ninety eight and 22nd of American Independence
