This Indenture made the fourteenth day of March in the year of our Lord one thousand seven hundred and Ninety Seven between William Hamby of the State of South Carolina and County of Granville of the one part and Isaac Preston of the said County & State of the other part Witness both that the said William Hamby for and in consideration of the sum of fifty pounds Sterling

185 Money to him in hand paid by the said Isaac Preston (the receipt whereof is here by acknowledged) he the said William Hamby hath Bargained and sold and by these presents doth bargain & Sell unto the said Isaac Preston a certain tract or parcel of Land lying & being in Granville County one branch of Ennore River containing by Estimation five hundred acres be the same more or less being part of a tract of Land originally Granted to Nathaniel Conner Beginning at a Poplar on a branch the old Steeking house stands upon and running a conditional line Between said Preston and Henry Chambley up the south side of said branch to the Head of said Branch thence to go a conditional mark line to post oak corner on corner ^{old} line thence with said old line South 60 to a post oak corner thence E. 100 to a Red oak thence N. 3.
