 This indenture made this twenty fourth day of September in the Twenty Third year of the Independence of the united States of America & in the year of our Lord 1798 between Abraham Bradley of the State of S^c Carolina & County of Greenville of the one part & George Bradley of the County & State aforesaid of the other part Son of the said Abraham Bradley Witnesseth that the S^d Abraham Bradley for & in consideration of the natural love & affection which he hath & beareth unto the said George Bradley & for the better maintenance and lively hood of him the S^d George Bradley hath given & granted a lined Entailed and Confirmed & by these presents doth give unto the S^d George Bradley his heirs and assigns all that Messuage or tenement Situate in the County aforesaid upon waters of Saluda River Armstrongs Creek Occupied by the S^d George Bradley containing one hundred and fifty acres of Land more or less Beginning upon a Red oak upon William Maslins line Running West a Conditional line between S^d George Bradley & Thomas Bradley to a white oak upon Armstrongs Creek thence a Crossed Creek & West a Conditional line between S^d George Bradley & James Brucettes stake thence South to a Red Oak a conditional line thence to the S^d Abraham Bradleys Original line to a stake thence the Original to Armstrongs Creek thence East a conditional line between S^d George Bradley & John B. Blackwell to William Maslins line thence along Maslins line to the beginning
