have granted bargained and sold and by these Presents do grant bar-  
gain sell and release unto Vincent Harrison the plantation  
or Tract of land whereon I now live Containing One hundred and  
thirty Acres more or less for and in consideration of the sum of One  
Hundred & fifty dollars the Receipt is hereby acknowledged which  
land was granted to Paul Fountain & from Paul Fountain to Robert  
Cannon by a lease & release bearing date the Seventh day of March  
One thousand seven hundred and ~~eighty~~ <sup>eighty</sup> Nine, and from Robert Cannon  
to Robt. Harrison as will more fully appear by the Records of Greenville
