E. on Vacant Land when surveyed Originally Granted to Badwalder Jones by his Excellency Thomas Pinckney on the third day of December one thousand seven hundred & Eighty Seven Reference being had to the Original Grant will more fully appear Now this one hundred acres more or less being laid out unto Samuel Brasher as follows Beginning on a small black Oak Corner on the Original line & running on the said line S. 23 W. on the said line to a black Oak Corner. From thence running S. 15. W. 13. to a post Oak from thence S. 65. E. to a stake from thence N. 55. E. 23. 56 to a post Corner from thence N. 15. E. 23 chains to a post Oak Corner. from thence N. 40. E. to a white Gum Corner on the South side of the S. Baker's Creek from thence running up & bounding on the said creek to a maple Corner on the North side of said Creek and from thence Northward through the said land to the Beginning.
