Benson of the District of Greenville Have granted bargained & sold & released by these presents Do grant bargain sell & release unto the sd. Robt. Benson a plantation tract of Land containing three hundred acres more or less situated in Greenville dist & bounded on one side by a fork of Enore river, being part of a tract of land granted Lachariah White by his Excellency Mr. Moultrie on the 18th day June 1785 bounded as follows Viz. Beginning on a pine tree N. 65° W. 35. to a living cattail branch to a pine tree N. 57° W. 43. to a post oak tree N. 17° E. 25. to a black oak tree N. 47° E. 40. to a black oak tree a conical hollow to the Beginning main between S. 60. Zack Hawee & Mr. Jordan Together with all & singular the rights members hereditaments and appurtenances to the said premises belonging or in any wise incident or appurtenant. To have and to hold all & singular the premises before mentioned unto the sd. Robt. Benson his heirs & assigns forever. And I do hereby bind myself my heirs Executors & Administrators to warrant & forever defend all & singular the said premises unto the sd. Robt.
