Whorton it being the same lands wheron S. Whorton formerly lived the tract originally granted to James H. Lomis by His Excellency Peter Brownes & his joining the other tract on the northeast side this containing one hundred & fifty acres both tracts containing three hundred & fifty acres be the same more or less bounded on the east side by Robert McFee's land on the west by said William Chandler's land and on the north and north east by lands belonging to Anthony Griffin and Martin Ayres, with all & singular the rights, members hereditaments & appurtenances to the said Remises belonging.
