


This Indenture made this the twenty ninth of January in the year of our Lord
 one thousand eight hundred and five between Walter Burrell of the one part and
 Joshua Gornell of the other part both of Greenville District & State of South Carolina —
 Witneseth that for and in consideration of the sum of one hundred Dollars to him in hand paid
 by said Joshua Gornell before signing and delivering of these presents the receipt whereof
 is hereby fully acknowledgd. Hath bargained and sold and by these presents Grant
 bargain and sell alien release and confirm and convey unto Joshua Gornell his
 heirs & assigns forever, two certain tracts or parcels of land they are situated lying & being
 (in the) district and state aforesaid, on fortion Berries fork of Tygar river, Beginning
 at a locust tree running N. 56. W. 53. to Post oak thene N. 22. 30. to hickory S. 60. E. 95
 to red oak S. 68. E. to Jipe Bakers corner thene along Jipe Bakers line to the
 Beginning, Containing by Estimation fifty acres be the same more or less. Being granted
 and Pattered to Wm Lynch bearing date the 21st day of January A.D. 1785 and by said
 Lynch conveyed to Brits Prent and from said Prent to Walter Burrell and from
 said Burrell to Michael Prent and now again conveyed from Michael Prent
 to said Burrell, and again conveyed from said Walter Burrell to Joshua Gornell —
 Together with another tract situated and being in the county and state aforesaid
 and watercourses aforesaid, beginning at a Spanish Oak thene N. 45. chains along
 Edsons to white Oak, thene S. 68. W. 20. Spanish Oak thene S. 85. E. 8 to chestnut
 thene S. 50. W. 28. 50. to a W. oak thene S. 68. E. 36 to a spanish Oak thene S. 23.
 E. 24 to a chestnut N. 60. E. 2. 90. to beginning, by Estimation one hundred and
 twenty six acres be the same more or less. Being granted and Pattered to the said
 Michael Prent, bearing date the 28. of May date 1799. Together with all and sin-
 gular the rights, members hereditaments and appurtenances to the said premises
 belonging or in any wise appertaining, To have and to hold all and singular
 the said premises before mentioned unto the said Joshua Gornell his heirs and assigns for-
 ever, and I do hereby bind myself my heirs Executors and administrators, warrant
 and forever defend all and singular the said premises unto the said Joshua
 Gornell his heirs and assigns against myself & my heirs & against every other
 person whomsoever lawfully claiming or to claim any part of the same
 In witness whereof I have hereunto set my hand and seal this the 27th day
 of January 1805. it being the twenty ninth year of the Independence of
 Sigma Sealed and delivered in the presence of
 Test. Abner Senter James Pennington } — Walter Burrell 

Greenville District. Personally came Abner Senter and makes oath and sayeth
 that he saw Walter Burrell sign and acknowledge the within deed of Conveyance
 unto Joshua Gornell for the purpose mentioned and that James Pennington was
 a Subscribing witness with himself at the same time. Sworn to before me
 this 1st day of November 1806 — John Tubb J.P.
