 of the sum of Two hundred Dollars to me in hand paid by the said Alexander McKinny
 before the sealing & Delivering of these presents, the receipt & payment whereof is hereby
 acknowledged, Have granted bargained sold & released and by these presents Do grant
 bargain sell and release unto the said Alex. McKinny a certain tract or parcel of land
 containing ninety two acres. Situate & lying in the district of Greenville on a branch of
 North Pacoletts river, which said tract of land was originally granted to Baylis Earle
 & William Benson Deceas^d as will appear by the patent and plat of the same - the same
 - real courses & boundaries thereof, being therein plainly described and delineated -
 Beginning on a poplar on the side of a hill & running thence South fifty East forty six chains
 to a white oak by a locust east side of a branch, thence north forty ch. east 20. to a stake
 on a little mountain (or large hill), thence north fifty ch. west forty six to a stake thence
 N^o forty east twenty chains to the Beginning - Together with all & singular the rights &
 Tithes here attachments and appurtenances to the said Premises belonging or in any wise
 appertaining. or incident thereto. To have & To hold all and singular the Premises
 beforementioned unto the said Alexander McKinny his heirs & assigns forever, and I
 the said Jacob Franks do hereby bind myself my heirs Executors & admors to warrant
 and forever defend all and singular the said premises unto the said Alex. McKinny
 and to his heirs and assigns against myself & my heirs and against all & every other
 Person or Persons whomsoever lawfully claiming or to claim the same or any part thereof.
