we Erasmus Ford & Levi Ford both of the State and District aforesaid for and in Consideration
of the sum of Two hundred and fifty Dollars to them in hand paid by Micajah Thomas
Smith of the State and District aforesaid the receipt whereof is hereby acknowledged
Have granted bargained and sold and Released, and by these Presents do bargain and
sell and Release unto the said Micajah T. Smith now living & being in the State &
District aforesaid, in the cove of Green river, on both sides of Ferry Creek, waters of
Green River, Containing three hundred and forty eight acres of land be the sum
more or less. Beginning on Eli. Fords poplar corner, thence John Cobins Conditional line
thence with said line to Fords back line to a white oak, and thence with said line
to William Cobins Conditional line, and thence with said line to Fords old line
and thence with said old line to a black gum, thence to the conditional line be between
Erasmus Ford & Levi Ford thes^r Conditional line begining at the head of a
branch that runs down between the house of Erasmus Ford and the apple orchard
field, thence down said branch to Ferry Creek, thence up the said creek, to the mouth
of a branch that runs down by Stephen Morgans old house thence up the said branch
to the Beginning corner, the same being granted to John Ford the nineteenth day of
February in the year of lord 1795. by his Excellency Charles Pinckney Esq. Governor
Commander for the time being. Together with all and singular the rights mem-
bers Hereditaments and appurtenances to the said premises belonging or in any wise
appertaining. To Have & To Hold all and singular the Premises before mentioned
unto the said Micajah T. Smith and his heirs forever we do hereby bind our-
selves our heirs Executors and Administrators to warrant and forever defend
the appurtenances premises unto the said Micajah T. Smith from us and our heirs
and from any other Person claiming the same or any Part thereof. In witness where-
