trict of Greenville and State aforesaid, for consideration of the sum of one hundred Dollars to me  
in hand paid by James McDaniel of the State and District aforesaid, Have Granted bargained sold  
and released and by these presents do Grant bargain sell and Release unto the s<sup>r</sup> James McDaniel  
a plantation or tract of Land, Containing seventy acres more or less, lying in the State and district  
aforesaid on a branch of reedy river, the south side of the same, Bounding & Beginning on the Spring branch  
thence running along the original line, to a conditional Stake corner near to a cotton field now  
intervened by me, thence running along a conditional line to a Stake on the original line thence  
running along the original line across the big wagon road to pines conditional corner the same along  
the conditional line to the head of the Spring branch thence down the Spring branch the water to be  
the line, to the beginning, it being a part of a tract of land originally granted to Valentine  
Harlin and assigned by his Excellency Charles Pinckney on the third day of Decr 1792  
as by a plat annexed to the s<sup>r</sup> Grant which will more fully appear, with all and singular  
the rights members appurtenances to s<sup>r</sup> premises belonging or in any wise incident or appur-  
taining, To have and to hold all and singular the premises before mentioned unto the said  
James McDaniel his heirs Exec<sup>t</sup> & administrators to warrant and forever defend all and singular  
the seventy acres of land more or less with the Premises unto the s<sup>r</sup> James McDaniel his heirs and  
assigns, against myself my heirs and assigns, and against every other person or persons — —

thousand Eight hundred and Seven, sign, sealed, and delivered in the presence of
