The State of South Carolina, Know all men by these presents that I Archabal Elliott of
 the District of Greenville & State aforesaid, in consideration of the sum of one hundred and forty
 dollars to me paid by Samuel M. Crow of the district of Newberry & State aforesaid, Have
 Grant bargain sold and Released, and by these presents do Grant bargain sell and release unto
 the said Samuel M. Crow all that plantation or tract of seventy four acres, be the same more or less
 it being part of a tract originally granted to Archabal Elliott Situate in Greenville District
 on Burrows Creek of the waters of the Middle fork of Saluda river, for 149 acres, Beginning at a
 post oak \times , running N. 52. W. 21. to a white oak \times , thence N. 38. E. 30. to a Stake \times thence S. 57. E. 55. to
 a pine \times thence N. 38. E. to a hanc on the said line, thence down the said branch to the creek
 thence straight out from the creek to the original line, thence S. 38. W. along the original
 line to the Beginning. Together with all and singular the right members hereunto, &
 appurtenances to the said premises belonging or in any wise incident or appertaining
 To Have and To Hold all and singular the premises before mentioned unto the said Samuel
 M. Crow his heirs and assigns forever, And I do hereby bind myself my heirs executors and
 administrators to warrant and forever defend, all and singular the said premises unto the
 said Samuel M. Crow his heirs and assigns, against myself and my heirs, and against all
 and every person whomsoever lawfully claiming, or to claim the same or any part thereof
 Witness my hand and seal this fourth day of February in the year of our Lord one thousand
 -and Eight hundred & four, in the twenty Eighth year of the independance of the United
 States of America - signed sealed and Delivered in presence
