Bounded by line running S^E 45° E. by John Mayfield S^W by Solomon Hornbuckle N.E. by the said Benson's land. Together with all and Singular the members hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining. To have & to hold all and singular the premises before mentioned unto the said Henry & Joshua Benson to them their heirs and assigns forever.
