 of Greenville District and State aforesaid in the consideration of the sum of two hundred  
 dollars to me paid by Hosea Garrett of the state and district aforesaid - the receipt  
 whereof is hereby acknowledged, Have granted bargained sold and released and by these  
 presents unto the said Hosea Garrett his heirs or assigns a certain tract or parcel of land  
 containing one hundred acres more or less situated in Greenville District aforesaid on a branch  
 of the north fork of Saluda river, and runs as follows viz Beginning on John Bates  
 corner running thence with sommng line to Babell Smithson's line thence with said  
 Smithson's line to a branch thence up said branch to the Toogaloc Road thence of the  
 right hand fork of said branch to the original line thence with said line to John Bates  
 corner thence with said Bates line to the Beginning corner. Together with all and  
 singular the rights members hereditaments and appurtenances to the said premises belong-  
 ing or in any wise incident or appertaining to have and to hold all and singular  
 the premises before mentioned unto the said Hosea Garrett his heirs and assigns forever  
 and I do hereby bind myself my heirs executors administrators and assigns to warrant  
 and forever defend all and singular the said premises unto the said Hosea Garrett his  
 heirs or assigns against myself my heirs and against all and every other person  
 or persons whomsoever lawfully claiming or to claim the same or any part thereof.
