This Indenture made this last day of December one thousand Eight hundred and
 Eight between Archer Brooks of the County of Montgomery & State of Kentucky of the one part
 and Elliott Clardy of South Carolina and District of Greenville of the other part. Witnesseth
 that the said Archer Brooks for the consideration of the sum of One hundred and fifty
 Dollars in hand paid by said Elliott Clardy the receipt hereof is acknowledged that & the
 said Archer Brooks, Have granted bargained & sold unto the said Elliott Clardy a part of
 a tract of land originally granted to Young Griffen bearing date the first of December 1794
 the land lying on the beaver dam Creek water of Enace River bounded as follows Viz
 Beginning on a white oak corner on S. Clardy's line thence along said line to a red oak
 corner thence along said line to a branch thence up said branch to a stake on the old
 line thence on the old line running S. E. to a stake corner thence a conditional line
 made between Young Griffen and Page Pickett to a red oak station thence to a Chestnut
 corner S. old line thence N. 63 E. to the beginning corner containing within the boundaries
 two hundred acres be the same more or less, Together with all and singular the
 rights members hereditaments & appurtenances to the said premises belonging or in
 any wise appertaining. To have and to hold all and singular the premises before
 mentioned unto the said Elliott Clardy. and I do hereby bind myself my heirs
 Executors & adm^{rs} & assigns to warrant and forever defend the above mentioned
 premises from me and my heirs and from any other person or persons lawfully
 claiming the same or any part thereof. to the S. Elliott Clardy & his heirs forever
 In witness whereunto I have set my hand and seal the day & date above
 mentioned. signed sealed and delivered in presence of us
