Grant of the State and District aforesaid in Consideration of the two hundred & fifty  
dollars to me in hand paid by Jeremiah Forrest of the same State and District, Have  
granted bargained, sold and by these presents do grant bargain sell and release unto  
the said Jeremiah Forrest two plantations or tracts of land lying & being in the District  
aforesaid on both sides of the South fork of Tygan River, containing one hundred and  
forty four more or less, & bounded as follows the one on the N.W. by land laid for  
Mary Vernon all other sides vacant land the other a part of said Mary Vernons tract  
the first Beginning on a poplar thence S. 36 E. 37. 20 to a stake thence N. 83. W. 27. to a  
oak thence N. 45. 10 to a dogwood thence N. 80 W. 18. to a Chesnut thence N. 19. to a  
hickory thence E. 27. 50 to the Beginning. the other Beginning on a black oak thence  
fifty one Chains to a black oak thence East 25. 00 to black oak thence S. 27. 50  
a post oak thence a conditional line to the Beginning. Together with all and singular  
the rights members hereditaments and appurtenances to said land & premises  
belonging or in any wise incident or appertaining. To have & To hold all and singular  
the land and Premises before mentioned unto the said Jeremiah Forrest his heirs &  
assigns forever, and I do hereby bind myself my heirs Exec<sup>rs</sup> & adm<sup>n</sup> to warrant  
and favour defend all and singular the said premises unto the said Jeremiah  
Forrest his heirs &c, against myself & my heirs or any other Person or Persons lawfully  
Claiming or to claim all or any part thereof. Witness my seal this eighteenth day  
Juni<sup>o</sup> the thousand eight hundred and eight. Intended before signed in the ninth line & four words from the
