

The State of South Carolina; Know all men by these presents that I John H.  
Harrison of the district of Pendleton and State aforesaid, for and in consideration  
of the sum of one thousand dollars to me paid by James Harrison Senior  
of the District of Greenville and same State, aforesaid, HAVE granted bargain  
and released and by these presents do grant bargain sell and release  
unto the said James Harrison three certain tracts or parcels of land all situate lying  
and being in the district of Greenville, aforesaid town, one of the said tracts containing  
three hundred and thirty seven acres, being part of a tract of six hundred & forty  
acres originally granted unto John Backharrison lying on a branch of Reedy River,  
Beginning on a white oak 3<sup>t</sup>, thence S.52.50 on John H. Harrison's line to a stake 3<sup>t</sup>  
thence south to a stake East 18.50 a red oak 3<sup>t</sup>. thence south 18.50 to a red oak  
thence East 28.50 to a stake 3<sup>t</sup> thence North 37.50 to a red oak 3<sup>t</sup> thence N.38.50  
to a stake by a white oak 3<sup>t</sup> thence west 47 to the Beginning, except so much of  
the aforesaid tract as I have heretofore conveyed to Fleming Hatchett; one other of  
the aforesaid tracts containing fifty five acres originally granted to Roadham  
Sutrell bounded by a line running West on William Choice thence West 40 to a  
red oak 3<sup>t</sup> thence South 23 to a black oak, on Kelly's line thence N.05 E.45 to a  
w. oak 3<sup>t</sup> thence North to the Beginning; and the other tract containing one hundred  
and three acres more or less, situate on Reedy River, Beginning on a beach 3<sup>t</sup>  
on said River running thence east 25:10 on James Kelly's line to a rock 3<sup>t</sup> thence  
N.17:20 on Chandler's line to a red oak 3<sup>t</sup> thence West 60 to a beach on Reedy  
River, thence down said River with its meanders to the Beginning, being part of  
a tract of 640 acres originally granted to John Wim; Together with all rra  
singular the Rights, members, hereditaments & appurtenances to the said premises belonging or  
in any wise incident or appertaining, To have & to hold all and singular the said  
premises aforesaid to the exception therein made) unto the said James Harrison Senior his  
heirs and assigns forever; And I do hereby bind myself my heirs Executor & Administrator  
to warrant and forever defend all and singular the said premises unto the said James  
Harrison Senior his heirs & assigns forever against myself and my heirs and against  
every other person or persons whomsoever lawfully claiming or to claim the same
