E 9. 50 to a rock 37 thence N 61 W. 16 to a dead Chestnut, thence N. 10. E 41. 75 to a pine 37 thence S. 80 E 10. 50. to a line, 37 thence N. 10. E. 13 to an Iron wood 37 thence N. 77. E 40 to a rock 37 thence S 10 W 8. 50 to a hickory 37 thence S 16 E 21. 50 to a red oak 37 thence S 84. E. 4. 50 to a red oak 37 thence S 62 E 10. 70 to a red oak 37 thence S 59. W. 24. to a red oak Sapling thence N 78. W 10, 50 to a persimmon 37 thence 11. 50. to a corner near the branch, thence S 70 W 9.
