sum of one Hundred Dollars to me in hand paid by Isaac Towers, of the  
same district and State aforesaid, the receipt whereof is hereby acknowledged  
to be satisfied and paid and for the said sum hath granted bargained & sold and  
by these presents do grant bargain & sell unto the said Isaac Towers to him  
his heirs Executors admt<sup>r</sup> or assigns One Hundred acres of Land situate lying  
on the branches of Greeland Creek the waters of Enoree River, beginning on a  
stake on Peaks line, running S. 70. W. 13 chain 50 links to a stake then S  
7chain 25 links to a stake then N. 78 W 18 chain 30 links to a red oak, then S 58  
19 chain 50 links to a maple by a branch, then up a small fork of said branch  
11 chains to a red oak, then N. 2. W. 25 Chains to pine then N 77. W. 1 1/2 Chain 75  
links to black Jack then N. 17 Chain to pine stump then S. 76. E 40 chain to  
beginning, to include all in said bounds for one hundred acres of land at there  
be more or less. Together with all the premises and appurtenances thereto  
belonging to the only proper use & behoof of him the said Isaac Towers him
