that Whereas, James Harrison Senior in his life time by his last Will & Testament did lend the said Jane Wright during her natural life or her pleasure to Continue on it provided she lived single or as she was at that time, his Dwelling house, together with all the furniture, except the books, together with two hundred acres of land to be laid off as she might direct; the property so lent to her, to fall back to the estate at her death removal or marriage - And Whereas it is most conducive to the interest of the said Jane Wright, as well as the rest of the persons above named, that the said Jane Wright should accept of other property in Lieu of her Estate in the said House land and furniture which she derived under the said Will. Now therefore be it known that the said Jane Wright hath, and doth by these presents release and quit claim all the interest which she had or hath in the said House & premises under the said Will, and doth Covenant and agree to and with the said parties last named, that her interest in the same as derived from the said Will shall cease & determine, and shall revert to the Estate of James Harrison deceased in order to be equally divided in fee simple among the heirs including herself, or sold as may be most advantageous. And the parties last named do hereby covenant and agree to and with the said Jane Wright that she shall receive out of the said estate not heretofore divided & disposed of the following articles, and things in lieu of her said Estate in the premises, to wit - one Chair and harness, three hogs in the pen fattening, thirty barrels Corn, all the spun yarn and new cloth, five hundred pounds of ^{the} bacon, one half of the Sugar & Coffee on hand, two Cows and calves, that bag of Cotton which is broke, two ploughs and gears, three hoes, all the poultrie, thirty dozen of oats, two stacks of fodder, all the furniture household and Kitchen, twelve bushels of wheat, thirty pounds of hogslard, and the Loom & gear; & shall besides have an equal distribution of all the property not disposed of.
