Road thence north forty one degrees East fifty three chains to a Red oak stump  
thence North Eighty degrees East one chain and fifty links to a stake thence  
East twenty two chains to a hickory thence South seven degrees East thirty  
three chains to a Red oak bush thence North Eighty three degrees East  
Ten chains to a lightwood stake thence South thirty four degrees West  
forty seven chains to a Red oak thence South thirty nine degrees West

to myself and part of a tract of four thousand acres of Land granted to Peter  
Pierce by grant bearing date the seventh day of March one thousand seven  
hundred and Eighty Eight and conveyed by said Pierce to David M. Vay  
and by said M. Vay conveyed to Isaac Wilkins and by said Wilkins conveyed  
in part to Edwin Lunsford a part to William Johnson and the balance of his  
purchase he conveyed to myself; Lunsford's part said Lunsford conveyed to  
William Walton and Walton conveyed it to myself and the part conveyed by  
Wilkins to Johnson said Johnson conveyed to myself making in the whole the  
number of acres before mentioned more or less Together with all and singular  
the Rights, members, hereditaments and appurtenances to the said premises belonging  
or in any wise incident or appertaining To Have & To Hold all & singular  
the premises above mentioned unto the said Jeremiah Wilcox his heirs and  
assigns forever and I do hereby bind myself my heirs executors & administrators  
to warrant and forever defend all and singular the said premises unto the said  
Jeremiah Wilcox his heirs and assigns against myself my heirs executors and  
administrators and against all and every other person or persons whomsoever  
lawfully claiming or to claim the same or any part thereof In Witness whereof  
I have hereunto set my hand and affixed my seal the twenty fourth day  
of August one thousand Eight hundred and fifteen, Provided always I  
reserve to myself one half acre including the burying ground with a passage
