 all and singular the premises within mentioned & retain  
 Given under my hand and Seal this 15<sup>th</sup> Day of July

 bered that on this July 1816 Richard R<sup>d</sup> Mullican  
 came before me & saith on his oath that he was present  
 and saw Tho<sup>s</sup> Mullican sen<sup>r</sup> sign & his act & seal & did  
 deliver the within deed of conveyance to Douglas Childers  
 for the use and purpose therein mentioned & that he  
 saw Tho<sup>s</sup> Mullican Junior subscribe their names as Witn-  
 eses, to the same sworn to and subscribed 23 July 1816

 Witnessed March 31<sup>st</sup> 1817

 unto John Meares his heirs and assigns forever - All that  
 plantation or tract of land, on which said Douglas Child-  
 ders, now lives, containing Sixty acres Situate in the State & District  
 aforesaid, on the waters of Horse creek Beginning at a State corner  
 on Thompson Bristers line Thence N<sup>o</sup> 60 E 25 chs 50 l<sup>ks</sup> to a stake  
 corner on said John Meares line, Thence N<sup>o</sup> 30 W 19<sup>ch</sup> 50 links to  
 a stake corner on John Chandler Sen<sup>r</sup> line Thence N<sup>o</sup> 45 W 6<sup>ch</sup>  
 40 l<sup>ks</sup> to a hickory corner on Lemus Rice line Thence S<sup>o</sup> 60 W  
 22 chains to a black oak corner on Tho<sup>s</sup> Mullican Sen<sup>r</sup> line Thence
