Earle for the uses and purposes in it Mentioned & that Elias Alexander was a Subscribing witness with himself to the execution of the same sworn & subscribed to before me this first day of June 1818.

Know all men by these presents that I John Goode of the State of South Carolina & County of Greenville for & in consideration of the sum of Four Hundred Dollars to me in hand paid by Richard Young of the County & State aforesaid have Granted Bargained sold & Released by these presents to Grant Bargain sell & Release unto the said Richard Young all that Plantation or tract of land wherein I now live containing three hundred acres to the same more or less situate on the West side of the North fork of Saluda River Beginning on a Willow tree on the bank of said River running thence with Samuel Earles line to a Stake on Foster's branch thence up the S<sup>d</sup> branch to the head from thence to the School house branch thence down the S<sup>d</sup> branch to Grants Spring branch thence up the said branch to the head striking Elias Earles line thence along the said line to a Stake at the mouth of a creek on the said River thence up the meanders of the River to the beginning together with all & singular the rights members hereditaments & appurtenances to the said premises belonging or in any wise incident or pertaining to have & to hold all & singular the premises before mentioned unto the said Richard Young his heirs & assigns forever & I do hereby bind my self my heirs & executors or administrators to warrant & defend all & singular the S<sup>d</sup> premises unto the said Richard Young his heirs & assigns against my self my heirs & every other person whomsoever lawfully claiming the same or any part thereof witness my hand & seal this twenty ninth of August in the year of our Lord one thousand Eight hundred & nine signed sealed & delivered in presence of
