State of South Carolina I know all men by these presents that I Joseph David of Spartanburg District in the State aforesaid for & in consideration of one hundred & fifty dollars to me in hand paid by Hugh Montgomery of Greenville District in the State aforesaid have granted bargained sold & released & by these presents do grant bargain sell release & confirm unto the said Hugh Montgomery all that tract or parcel of land containing one hundred acres be the same more or less situate in Greenville District aforesaid on both sides Thompsons Beaver Creek creek of Middle Tygar River bounded by a line running N<sup>o</sup> 22 W. from a Maple corner on S<sup>c</sup>. creek 38<sup>th</sup> 50<sup>ft</sup> to a Stake on Edwards Smiths line thence Eastwardly a long John Davis line to a P. Oak b<sup>r</sup> thene southwardly on S<sup>c</sup>. John Davis line to a White Oak on or near S<sup>c</sup>. creek & onward to a chestnut corner thence Westward to a Black Oak b<sup>r</sup> near a spring thence down the various meanders of said spring branch to the said creek thence up the meanders of S<sup>c</sup>. creek to the Maple b<sup>r</sup> the Beginning together with all & singular the rights Members hereditaments & appurtenances thereto belonging or in anywise incident or appertaining. To have and to hold all & singular the premises before mentioned unto the said Hugh Montgomery his heirs & assigns forever & I do hereby bind myself my heirs Executors & Administrators to warrant & forever defend him & singular the said premises unto the said Hugh Montgomery his heirs & assigns against my self & my heirs & against every other person or persons whomsoever lawfully claiming or to claim the same or any part thereof witness my hand & seal the nineteenth day of December in the year of our Lord one thousand eight hundred & twelve & in the thirty second year of the Independence of the United States of America signed sealed & delivered in presence of us —
