Pintney Hawkins Inv. of Greenville District in the Said State Plan-
ter, for & in consideration of the sum of Three hundred & twenty
Dollars to me in hand paid by Joshua Hawkins of the same place
Planter, have granted bargain sold & released & by these Pres-
ents do grant bargain sell & release unto the Said Joshua Hawkins
all that Piece parcel or Tract of land containing one Hundred acres
by the same more or less describe lying & being in the District & State
aforesaid on Langston's Creek waters of Roar River being part of a
tract of land originally granted to John Langston & by him conveyed
to Solomon Langston Inv. & from him to me & bounded as follows
Beginning on a Post or corner at the Waggon Ford of S. Neely's
Spring branch running thence With Youngs Waggon road Westw-
ards to a Persimmon corner at the Waggon ford of J. McClanahan
- and Spring branch thence up the Meanders of said branch to a
Hickory corner on McClanahans line thence With McClanahans
line to a White Oak on said Joshua Hawkins line of land he
bought of Bridges thence With that line to a Persimmon corner
made between A. Brison & S. Neely. thence With said Hick-
ory line to a Willow corner on his Spring branch, thence down
the Meanders of the branch to the beginning together with all and
singular the rights Members hereditaments & appurtenances to
the said premises belonging or in any wise incident or appur-
taining to have and to hold all & singular the premises
before mentioned unto the Said Joshua Hawkins his heirs
& assigns for ever. And I do hereby bind myself my heirs
executors and administrators to warrant & forever defend
all & singular the said premises unto the said Joshua Hawkins
his heirs & assigns against my self & my heirs & against
every other person or persons whomsoever lawfully claiming or
to claim the same or any part thereof witness my hand &
Seal this fourth day of July in the Year of our Lord one
Thousand eight hundred & Eighteen & 42^o Year of the American
