 of the sum of five hundred dollars to me in hand paid by Michael Jordan  
 of the State and district aforesaid hath bargained and sold and by  
 these presents do bargain and sell unto the said Michael Jordan all that  
 tract or parcel of land containing two hundred acres more or less, lying and  
 being in the district aforesaid on the waters of Mountain Creek originally  
 granted to Elizabeth Beal, from Beal to Tarrant from Tarrant to Grace  
 Bounding as follows Beginning on black Oak on Charter Estes line and  
 running S. 60 W. 57.50 to a White Oak & thence N. 80 W. 37 to a Post oak  
 joining land of the Heir of Larken Tarrant, thence N. 43. E 15 to a small  
 Hickory &c, thence N. 25 W. 30 to a Rock &c, thence N. 60 E 25 to a Stake on  
 Hockley Burloc line, thence S. 89 E. 25. 60. to the beginning. Together  
 with all and singular the premises before mentioned, with the rights mem-  
 bers hereditaments and appurtenances to the said premises belonging  
 or in any wise incident or appertaining; to have and to hold all and  
 singular the premises, before mentioned, unto the said Michael Jordan  
 his heirs and assigns for ever. And I do hereby bind myself  
 my heirs executors and administrators to warrant and forever defend  
 all and singular the said premises unto the said Michael Jordan his  
 heirs and assigns against myself my heirs & assigns and against every  
 other person or persons whomsoever lawfully claiming the same or any
