various meanders to a Box stem 3x thence \$2. 20 W. 6. 50 to a white oak  
3x on the creek thence up the creek 36 with its various meanders to a Stake  
3x thence N. 84 W. 6. 50 to a stake 3x thence N. 8. 88 to a stake 3x thence  
N. 57 W. 13 to a post oak 3x thence N. 21 W. 17. 50 to the Beginning corner.  
Situate & lying in the District Greenville on the south West side of  
the grave marsh waters of Saluda River together with all and sing-  
ular the rights members Hereditaments & appertaining to the said  
premises belonging or in any wise incident or appertaining to have  
and to hold all & singular the premises before mentioned unto the  
sd. Samuel Williams his heirs & assigns forever. & I do hereby bind  
my self my heirs Executors & administrators to warrant & forever defend  
and all & singular the sd. premises unto the sd. Samuel Williams  
his heirs & assigns against my self & my heirs & against every other  
person whomever lawfully claiming or to claim the same or  
any part thereof. as witness my hand & seal this twenty fifth  
day of July & in the year of our Lord one thousand eight hundred  
and twenty & in the forty fifth year of the Independence of the
