

291 State of South Carolina Greenville district Memorandum of a  
Contract this day entered into between Robert Goodgion of the one part  
and Joseph Goodgion of the other part Witnesseth that the said Joseph  
doth agree from this time forward to continue to live with the said  
Robert take care of & manage his affairs for him in the same  
Manner he has done heretofore during the natural life of the said  
Robert and in consideration of which the said Robert doth agree to give  
the said Joseph one third part of his whole Estate in which his  
negro boy Crook is to be included at his valuation at his the said  
Roberts decease which Consideration <sup>will</sup> more fully appear by the last  
will & Testament of the said Robert Goodgion which is consistent  
with this agreement likewise the said Robert doth agree to provide  
the said Joseph in comfortable clothes as he formerly has done  
Given under our hands this second day of March in the year  
of our Lord one thousand eight hundred & twenty one

291 This instrument made this 26<sup>th</sup> day of September in the year of our Lord one  
thousand eight hundred and eight in the thirtysixth year of American  
Independence between Gallant Eustis of the State of S. Carolina and  
Greenville District of the one part & Thomas Lynn of the other part  
living in the State & district aforesaid as witnesseth that for and in considera-  
tion of the sum of seventeen dollars paid in hand by the said Lynn  
whereof acknowledged by s<sup>d</sup> Eustis hath bargained & sold unto s<sup>d</sup> Lynn  
a certain parcel of Land containing fifty acres to the same more or  
less lying in the State & district aforesaid beginning at a pine corner  
of one of Stiles' old tracts Conveyed to John Sparks, thence to a stake on  
that line thence a crop to his other line to this Survey then a long  
line to a black oak corner thence to the beginning lying between  
Stiles' two surveys as above mentioned do grant to s<sup>d</sup> Lynn himself  
and his heirs & assigns forever the s<sup>d</sup> parcel of Land with all and  
singular the rights & privileges therunto belonging to s<sup>d</sup> Lynn  
and the said Eustis for himself his heirs & assigns do hereby  
dismiss & agree that he will at all times warrant and defend the said  
premises from himself his heirs & assigns or claim of any person or persons  
whatever whereby the said premises may be encumbered in witness  
whereof I have unto set my hand & seal the day & date above written  
in the presence of us Test.
