dollars to me paid by Walter Ashmore of the district and state aforesaid have  
Granted bargained sold & released, & by these presents do grant bargain sell and  
release, unto the said Walter Ashmore two tracts or parcels of land the one  
whereon I now live & the other bounded on the same tract to wit the first  
tract or parcel of land containing fifty Acres more or less beginning  
on a sassafras corner on the south side of a branch of Reedy River  
thence an Chamlin line thence a long a conditional to a Stake 3x thence  
along a conditional line to a stake 3x on Joshua Thompson line thence on said  
line to a red Oak 3x thence on said line to a post Oak 3x on Thomas Hanous  
line thence on said line to a post Oak 3x from thence on Daniel Hids -  
formerly Philip Chamlin to the begining a parcel or part originally gran-  
ted to Robert Ramsey on the fourteenth day of December 1786 the other  
part being originally granted by me on the 3<sup>rd</sup> day of August 1801 -  
Beginning on a post Oak on a direct line between Willis Hicks & A. Barrett  
line thence N. 17 Chain to a pine 3x thence N. 9 W. 16. 50 to a white oak -  
Conditional corner, thence a strait line to a chestnut corner to the big  
branch thence up the said branch to Jordan Hicks corner, thence along  
said line to a conditional corner thence S. 45 W. to a post oak 3x thence S.  
45. E. 20 Chains to a Red Oak 3x thence S. 4 E. 2. Chains to a black oak 3x -  
thence S. 4 E to the begining corner containing twenty Acres of land more  
or less together with all and singular the Rights members Hereditaments  
and appurtenances to the said premises belonging or in any wise Incident  
or appertaining to have and to hold all and singular the premises

forever and I do hereby bind myself - Heirs, Executors and Administrators to -  
ward - and for ever defend all and singular the said premises unto  
the said Walter Ashmore, his heirs and assigns against my self and my heirs  
and against every other person or persons lawfully claiming or to claim  
the same or any part thereof Witness my hand and seal this 20<sup>th</sup> day  
of December in the year of our Lord one thousand Eight hundred and  
twenty six and in the fifteenth year of the Independence of the United States of  
America signed sealed and delivered in the presence
