



Charles Lucas of Spartanburgh District have granted bargained sold and leased and by these presents do grant bargain sell and release unto the said Charles Lucas a tract or plantation of land laying and being in the District of Greenville on the S. West side of Middle Tyeer River begining at a light wood stake on the bank of the River formerly Thomas Spencers corner thence N. 85. W. 27 chm. 50 lks to a black oak thence S. 75. W. 24. chm. to a pine knot thence S. 42. W. 9. chm. 50. lks to a post oak thence S. 45. E. 30 chm. to a black oak thence N. 65. E. 32. chm. to a hickory thence E. 25 chm. 50 lks to a stake on the bank of the River near a post oak sapling thence up the meanders of the River to the begining containing by Estimation one hundred and forty nine acres be the same more or less being the S. West End of a tract originally granted to John Spence and by him conveyed to Valentine Ponder and by and from him to me. Reference to the several titles will make this title more fully appear. Together with all and singular the rights, mumber hereditaments, and appertinances therunto belonging or in any wise appertaining to have and to hold the above mentioned premises unto the said Charles Lucas his heirs and assigns for ever and I do hereby bind myself my heirs and Executors to warrant and for ever defend the above mentioned premises unto the said Charles Lucas his heirs and assigns against me and my heirs and against every person or persons whomsoever lawfully claiming or to claim the same or any part thereof. In witness whereof I have hereunto set my hand and seal this twenty first of August in the year of our Lord One thousand Eight hundred and twenty seven, fifty first & fifty second of the American Independence signed sealed & delivered in presence of David R. ^{his} Watson, William Page & Ed. Know all men by these presents that I Dion Gambelin of Greenville in the State aforesaid for and in consideration of the sum of \$12 to me in-paid by James McDaniel of Greenville in the State aforesaid have granted bargained, sold and released and by these presents do grant bargain, sell and release unto the said James McDaniel Twelve acres of land, adjoining of said McDaniel, to commence on begining on the Spanish Oak corner of the said Gambelin thence N. E. to the Hickory stump at the Post thence to a small red oak corner thence near an East course to a large red oak near the Long branch thence near a South course on said McDaniel's line so far as to include the said 12. Acres of land by running a straight line to the Begining Spanish Oak corner. Together with all and singular the rights, mumber hereditaments, and appertinances to the said premises belonging or in any wise incident to have and to hold all and singular the premises before mentioned unto the said James McDaniel his heirs and assigns for ever and I do hereby bind myself my heirs Executors and Administrators to warrant and for ever defend all and singular the said premises unto the sd. James McDaniel his heirs and assigns against myself and my heirs and against every other person whomsoever
