 conveyed and confirmed and by these presents do grant bargain
 in, sell release convey and confirm unto the said Erwin P.
 Pool his heirs and assigns a certain plantation tract or parcel
 of land containing one hundred and thirty eight acres situate
 in Granville District on both sides of the Middle fork of Saluda
 River Surveyed for John Postman Sen. on the twenty sixth day
 of July one thousand seven hundred and eighty five and a part
 by and granted to Marcus Littleton and by him conveyed to Charles
 Littleton, and by said Charles Littleton conveyed to John Hankins
 and by the said John Hankins conveyed to the above named
 Stephen C. Wood and runs as follows that is to say. Beginning
 on a Stake on the East side of the Middle Fork of Saluda River
 thence South sixty two degrees west. west fifty eight Chains to a red oak
 thence South twenty eight degrees East twenty Chains to a Basselder thence
 South eighty five degrees East seven Chains to a chestnut thence North
 Sixty two degrees East fifty five Chains to a Stake thence North twenty
 Eight degrees west to the Beginning. Also an other tract of five hundred
 Acres of land adjoining the above described tract of land Surveyed for
 and granted to the above named Stephen C. Wood by a grant bearing
 date the fourth day of January one thousand eight hundred and two
