 N. 41 1/2 W. 14. 50 Small Hickory 3x thence S. 85. E. 5. to a large P. O. 3x thence
 N. 49. W. 25. to the beginning corner including twenty eight acres
 more or less together with all and singular the rights, members
 incidents and appurtenances belonging or in any wise appertai-
 ning to the same To Have & To Hold all and singular the premis-
 es therefore mentioned unto the said Silmon Davis his heirs and assigns
 for ever And I do hereby bind myself my heirs Executors and administra-
 tors to warrant and for ever defend all and singular the said premises
 unto the said Silmon Davis his heirs and assigns against myself and
 my heirs Executors & administrators and against every person or persons
