E. 15. 75 to a red oak 3x bounding on William Arnolds land thence S 76 E 7. 50 to a red oak 3x thence N. 19. E 26. 00 to a red oak 3x on a branch bounding on Joseph McCullaugh's land thence down the meanders of said branch on its general course N. 85. E. 38. 25 to its confluence with the beaver dam Creek thence down the meanders of said 31. 25 to a dead hickory 3x at the mouth of a branch thence N. 80. E. 14. 25 bounded by the meanders of said branch to the beginning, Together with all and singular the rights, liberties, hereditaments, and appurtenances to the said premises belonging or in any wise incident or appertaining To Have and to hold all and singular the premises before mentioned unto the said John Medlock his heirs and assigns for ever and I do hereby bind myself, my heirs, Executors and administrators to warrant and for ever defend all and singular the said premises unto the said John Medlock his heirs and assigns against my self and my heirs and against every person or persons whomsoever lawfully claiming or to claim the same or any part thereof Witness my hand and seal this sixth day of March in the Year of our Lord one thousand eight hundred and thirty and in the fifty fourth Year of the Independence of the United States of America, signed, sealed and delivered in the presence
