 Greenville District William Kennedy of Greenville in the state  
 of South Carolina in consideration of the sum of six hundred dollars  
 to me paid by Henry Darby of Newberry District and State aforesaid  
 have granted, bargained, sold, and released, and by these presents, do  
 grant, bargain, sell, and release, unto the said Henry Darby all that Plan-  
 tation or tract of land whereon I now live containing two hundred and  
 fifty acres of land more or less, situate on the south side of the State road  
 leading from John Hedges to Columbia on the waters of Enoree being the  
 same land I purchased of my father John Kennedy. Together with  
 all and singular the rights, members, hereditaments, and appur-  
 tenances to the said premises belonging or in any wise incident or appertain-  
 ing. To have and to hold, all and singular the premises before mentioned  
 unto the said Henry Darby his heirs and assigns for ever. And I do here-  
 by bind my self heirs, executors and administrators, to warrant, and for-  
 ever defend, all and singular the said premises, unto the said Hen-  
 ry Darby his heirs and assigns against my self and heirs and aga-  
 inst every person whomsoever, lawfully claiming, or to claim, the same  
 or any part thereof. Witness my hand and seal this nineteenth day of  
 Sept in the year of our Lord one thousand eight hundred and  
 thirty one in the fifty fifth year of the independence of the United  
 States of America. Signed, sealed, and delivered in the presence
