 possessed of certain lands laying in the State and District aforesaid
 and by his last will and testament directed his Executors their
 = in name to sell all his Real and personal Estate now we Me-
 -ajah Berry and Daniel Ford Executors of the estate of the said Step-
 -hen Ford Deed in consideration of the sum of Sixty five Dollars
 to us paid by James McElroy of the State and District aforesaid
 have granted bargained sold and released and by these presents do
 grant bargain sell and release unto the said James McElroy a sum
 = all tract or parcel of land laying in the State and District aforesaid
 Said on the waters of Reedy River being part of a tract of 300 acres
 of land granted to the said Stephen Ford on the fifteenth day of
 October 1784 Beginning at a Stake 3+ thence running S. 83 E. 28.50 to
 a Stake or Rock 3x. thence N. 49 E. 6.20 to a Stake 3+ thence N. 27 W.
 14.60. to a post oak 3x thence S. 63 W. 29.85 to the beginning contain-
 ing thirty acres be the same now or left together with all and
 singular the rights members hereditaments and appurtenances to
 the same belonging as in any case incident or appertaining to
 have and to hold all and singular the premises above mentioned
 unto the said James McElroy his heirs and assigns forever and
 we as Executors as aforesaid do hereby bind ourselves our Exe-
 cutors and assigns to warrant and forever defend all and singular
 the premises above mentioned unto the said James McElroy
 from every person whencesoever lawfully claiming or to claim
 the same or any part thereof witness our hands and seals this
 twenty seventh day of February in the year of our Lord one
 thousand Eight hundred and thirty and in the fifty fourth year
 of the Independence of the United States of America Signed
