Know all men by these presents that I Hardway Huff of Greenville district and State of South Carolina for and in consideration of the sum of three hundred and fourteen dollars to me paid in hand by John Payne of the district and State aforesaid at and before the Sealing and Delivering of these presents have Bargained and Sold and by these presents doth Grant Bargain Sell and release confirm and deliver unto the Said John Payne to him his heirs and assigns forever all that tract or parcel of Land Situate lying and being in the aforesaid State and district on Saludia River and containing two hundred acres more or less Beginning on a black gum corner on Said River and on D. Westfields line thence along Said line to a cypresswood corner thence North along Said Westfields and John Sonegus line to a poplar corner on line Branch thence down the Meanders of Said Branch to a beach corner on Saludia river thence down the Meanders of Said River to the Beginning Together With all and Singular the rights members Heredeterments and appertanances to the Said premises belonging or in any wise appertaining to have and to hold all the Said Bargained premises to the Said John Payne his heirs and assigns forever and I do by these presents bind myself my heirs and assigns to Warrant and forever defend the Said Bargained premises unto the Said John Payne his heirs and assigns against myself my heirs and assigns and against Every other person or persons lawfully blaiming or to blaim the Said Bargained premises or any parcel or part thereof In Testimony Whereof I do hereunto Set my hand and Seal this
