

Convey unto the Said Jeremiah Cleveland his heirs and assigns forever all my right title Interest and Estate being the one half of the following piece parcel or tract of Land containing in the whole nine hundred and sixty two and three fourth acres Situate lying and being the district of Greenville on the Waters of Saluda and Needy Rivers and for a more particular description of which reference must be had to the plat hereunto annexed in which the Land hereby conveyed is designated by the numbers three, five six & seven and together make nine hundred and sixty two and three fourth acres and also for and Inconsideration of one hundred dollars to me in hand paid by the Said Jeremiah Cleveland I have Bargained Sold released and by these presents do Bargain Sell and Release unto the Said Jeremiah Cleveland one other tract of land containing two hundred and nineteen acres more or less Situate lying and being in the Said district of Greenville on the Waters of the Said Rivers and for a more particular description of this tract reference must be had to a deed from the Said Nimrod Underwood Esqr late Sheriff of Greenville District to me dated the 31<sup>st</sup> day of August 1826 Together with all and Singular the rights members Hereditaments and appurtenances to the Said tracts of Land belonging or in any wise Incident or appertaining to have and to hold all and Singular the premises above described unto the Said Jeremiah Cleveland his heirs and assigns forever and I hereby bind myself my heirs and assigns to Warrant and forever defend all and Singular the Said premises unto the Said Jeremiah Cleveland his heirs and assigns against myself my heirs and against Every other person Whomsoever claiming or to claim the Same or any part thereof provided nevertheless that I only warrant one half of the first or large tract hereby conveyed and the whole of the last or smaller tract In Testimony Whereof I have hereunto Set my hand and affixed my seal to this deed this the 28<sup>th</sup> day of March A.D. 1834
