 sum that was bid therefor Now Know ye that I David Henning Sheriff afo-
 -said by virtue of the said writ of fieri facias aforesaid to me directed and
 delivered as aforesaid and by virtue of the Statute in such case made provided
 and for and in consideration of the said sum of Forty 84 dollars to me in
 hand paid or secured to be paid by the said David Hoke the receipt & paym-
 ent whereof I do hereby acknowledge have granted bargained and sold
 and by these presents do grant bargain and sell unto the said David
 Hoke his heirs and assigns forever the said tract piece and parcel of land
