Eliza Tally. } State of South Carolina To witness


Greenville District } To all people whom these presents shall  
 come I Arthur Barrett of the State and District aforesaid do send greeting Know ye that  
 I the said Arthur Barrett for and in consideration of the natural love and affection which  
 I have and bear unto my daughter Eliza Tally wife of Reuben Tally of the said State and  
 District and also for other good causes and considerations me hereunto moving have given  
 and granted and by these presents do give grant and confirm unto the said Eliza Tally  
 her heirs and assigns forever the following property to wit One negro woman Also and her  
 three children Daniel Phillips and Ruby together with the increase of said negroes To have  
 and to hold all and singular the said negro woman and children unto the said Eliza Tally  
 and the heirs of her body forever to her own proper use and behoof to belong to and owned  
 by and be enjoyed only by the said Eliza Tally and the heirs of her body forever and I the  
 said Arthur do warrant by these presents and forever defend the said negro woman  
 and children as above described unto the said Eliza Tally and the heirs of her body  
 forever In witness whereof I have hereunto set my hand and seal this first day  
 of February 1842.
