and District aforesaid have bargained and sold and by these presents do

grant, bargain sell and release unto the said A B Crook all that tract or
tracts or parcel of Land containing six hundred and eleven acres be the same
more or less lying in Greenville District on the North side of the North fork
of Saluda River Beginning on a white oak 3 ft tree on the point of the hill
near the lower end of T H Wileys bottom running thence N. 70° E. to a Stake on
an old road thence S. 4° E. 1.50 to a poplar thence N. 80° E. 7 to a Red oak thence
S. 35° E. 28 to a pine thence S. 9. 50 to a Stake thence S. 80° E. 21.50 to a Stake thence
N. 15° W. 17.50 to a Red oak thence N. 50° E. 60. to a white thence S. 75° E. 10 chains
to a Red oak thence N. 20° W. 5.70 to a Black oak thence N. 5. 70. 51.62 to a Post oak
thence N. 28° W. 8.20. to a Stake on Henry M Woods original line thence with
said line to Goodlets line thence S. 60° W. 54. to a Red oak thence N. 30° W. to
